

STAFFORD COUNTY ELECTORAL BOARD MINUTES  
JANUARY 4, 2021

The Stafford County Electoral Board met at the office of the General Registrar, 1300 Courthouse Road Stafford Va. 22554. Marie called the meeting to order at 11:25 AM.

Roll Call: Marie Gozzi, Chairman, Jim Minor, Vice Chairman, Gloria Chittum, Secretary, Anna Hash, General Registrar, also present was Dr. Brandynicole Brooks-Harris who is the new member to the Electoral Board replacing Marie. Marie gave her a warm welcome, and we all welcomed her. Marie made a motion to accept the minutes from the November 2, 2020 meeting, which concluded on November 9, 2020. Jim seconded, and all voted in favor.

Old Business: Marie asked Anna about the hiring of another Assistant Registrar and Anna said it is in the works.

New Business: Anna reported we had voted 360 in person early voters.

Wednesday, January 6, 2021 at 12:05 PM Marie called the meeting back into secession to begin the canvas of the special election held on January 4, 2021, Present were Marie Gozzi, Chairman, Jim Minor, Vice Chairman, Gloria Chittum, Secretary, Anna Hash, General Registrar, McKenzie Burton, Assistant Registrar, Dr. Bradynicloe Brooks-Harris, observer, and Tony DeTora, Chairman Stafford County Republican Party. The canvas was completed at 12:25 PM, and Marie made a motion to recess until noon on Friday, January 8 to complete the canvas by doing the Provisional Ballots. Jim seconded, and all voted in favor

On Friday January 8, 2021 Marie reconvened the meeting at 12:15 PM for the completion of the canvas. Present were Marie Gozzi, Chairman, Jim Minor, Vice Chairman, Gloria Chittum, Secretary, Anna Hash, General Registrar, McKenzie Burton, Assistant Registrar, Dr. Brandynicole Brooks-Harris, observer. There were 7 Provisional Ballots cast. Four (4) were counted, and three (3) were not counted. Canvas was completed at 12:35 PM. This being Marie's last meeting, we all thanked her for her service and we let her know it had been a pleasure to work with her. We all hope she will enjoy doing what she loves to do, and that is to travel.
