MINUTES

The Stafford County Electoral Board met on Monday November 1, 2021 at the General Registrar's office located at 1300 Courthouse Rd. Stafford, VA 22554. At 2:02, PM Jim called the meeting to order.

ROLL CALL: Present were Chairman, Jim Minor, Vice Chairman, Brandynicole Brooks, Secretary, Gloria Chittum, General Registrar, Anna Hash.

Approval of Minutes from October 19, 2021 Meeting: Brandynicole made a motion to accept. Jim seconded, and all voted in favor.

Old Business:

Change of time for the November 1, 2021 meeting from 1PM to 2PM.
