## MINUTES

NOVEMBER 7, 2022

The Stafford County Electoral Board met on November 7, 2022 at the General Registrar's office located at 1300 Courthouse Road, Stafford VA, 22554.

Jim called the meeting to order at 12:00 noon

**Roll Call :** Jim Minor, Chairman, Brandynicole Brooks, Vice Chairman, Gloria Chittum, Secretary, Anna Hash, General Registrar, and two visitors, Diana Hollister and John Roy.

Cliff asked why the hand counted ballots were counted at the White Oak precinct instead of at the England Run precinct. Gloria explained that White Oak had received a package of England Run's ballots by mistake, and the people who voted those ballots were in the correct precinct and that is where they needed to cast their ballot. Also, it's not legal to transport a voted ballot to another precinct. Jim recessed the meeting at 12:45 PM. The meeting will reconvene at 12:00 PM on Monday, November 14, 2022.
