STAFFORD COUNTY ELECTORAL BOARD

JUNE 12, 2017

The Stafford County Electoral Board met at the General Registrar's office located at 1300 Courthouse Road Stafford, Virginia 22554. The meeting was called to order by Chairman Doug Filler. Roll Call: Chairman, Doug Filler; Vice Chairman, Marie Gozzi; Secretary, Gloria Chittum, and General Registrar Riddlemoser were present. Minutes of the February 23rd, 2017 were read and approved. Doug called for any old business there being none we moved into New Business.

Greg confirmed Election preparation was complete and that we were ready for a 40% turnout. Greg advised we would have two (2) IT rovers to help with any IT problems that may arise. Greg also mentioned that we had run out of budgeted money, but the county had given us \$40,000.00 Dollars for this election. Greg then told us that Paul Milde had been fined (\$1100.00) eleven hundred dollars, Laura Sellers had been fined and Mark Dudenhefer had been fined – all for late filings. Officers of Election who had not been appointed previously needed to be added. Doug made a motion to accept the new officers, Marie seconded and all voted in favor. Greg advised us that the canvas on Wednesday at 10AM would be held in the Clerk of Courts Office but we will meet here at the registrar's office and from here be escorted to the clerk's office. Doug made motion to open the Provisional Ballots on Tuesday, Marie seconded and all voted in favor. Greg then discussed wanting to meet with the BOS for redistricting and possible need for new precincts, also would like to use 100% schools. Greg advised we need to send a letter to the School Board regarding this request and the change to the calendar for school closing during a primary as well as the general election. Greg also advised us that the BOS has given us money for cages for all of our election equipment. We need to do an annual ADA inspection and also to ensure cages will fit thru all the doors in building were the election is being held. Marie made motion to resolve to have the School Board change calendar for all elections Doug seconded all voted in favor. The Electoral Board will be involved in these meetings .Doug made a motion to adjourn Gloria seconded all voted in favor.

Wednesday JUNE 14, 2017

Doug call the meeting to order at 10 AM all board members present, along with General Registrar Greg Riddlemoser and his assistant Jincy Brown, Jase Davis (Republican Party) , and Sam Rivers from the King Camp. The canvas was completed. Doug made a motion we move into the Provisional canvas Gloria Seconded all vote to precede. We moved into the Provisional canvas this was completed. Doug made a motion to recess until Friday at 12 noon, Gloria seconded and all voted in favor.

FRIDAY JUNE 16th 2017

Doug called meeting to order with all present. There being no further provisional ballots, Greg discussed the upcoming recount House of Delegates District 2. Doug made motion to adjourn, Marie seconded and all voted in favor.
