

STAFFORD COUNTY ELECTORAL BOARD MINUTES  
NOVEMBER 2, 2020

The Stafford County Electoral Board met at the office of the General Registrar, 1300 Courthouse Rd, Stafford, VA 22554. Marie called the meeting to order at 1:05 PM.

**Roll Call:** Marie Gozzi, Chairman, Jim Minor, Vice Chairman, Gloria Chittum, Secretary, and Anna Hash, Registrar. Minutes for the July 31, 2020 were read and approved Marie made motion to accept, Jim seconded, and all voted yes.


**OLD BUSINESS:** There was no old business.

**NEW BUSINESS:** Anna reported we are ready for voting tomorrow. All equipment has been sent out, Gloria swore-in all the chief's today and gave them their Chief's package. Marie commented on training and the numbers of early voters. Anna reported 15,110 ballots have been returned through the mail. 3000 have not been returned as yet but are coming in daily. There were 33,323 people who voted early in per. 48,433 have voted which is 46%. Gloria made a motion to appoint the new officers of election. Marie seconded, and all voted in favor. There being no further business, Marie made a motion to recess until Tuesday for the election and to return for canvas on Wednesday, November 4, 2020 for the start of the canvas, Gloria seconded, and all voted in favor.

Wednesday, November 4, 2020 at 12:15 PM Marie called meeting back in session to stat canvas for the November 3, 2020 election. Present were Marie Gozzi, Chairman, Jim Minor, Vice Chairman, Gloria Chittum, Secretary, Anna Hash, General Registrar, McKenzie Burton, Assistant Registrar, Tony DeTora, Stafford County Republican Party Chair. L&A was conducted on a new machine to process ballots that were received through the mail after election day. After canvas was completed for election day precincts Marie made a motion at 2:20 PM to recess until noon on Monday November 9, 2020 to hold the Provisional ballot meeting and ballots received through the mail after election day. Jim seconded, and all voted in favor.

Monday, November 9, 2020 at 12:10 PM, Marie reconvened our meeting for the completion of the canvas. Present were Marie Gozzi, Chairman, Jim Minor, Vice Chairman, Gloria Chittum Secretary, Anna Hash, General Registrar, McKenzie Burton, Assistant Registrar, Tony DeTora, Stafford County Republican Party Chair. Marie made a motion to do Provisional Ballots. All voted in favor. L&A was conducted on a machine to run provisional ballots. After this was completed, 345 ballots were counted. Anna informed us she would have all the paper work ready for us on Tuesday, November 10, 2020 for us to sign and send to Richmond. Marie called to adjourn the meeting as there was no further business. Jim seconded, and all voted in favor.
