- 4. Which department is responsible for providing services to over 30,000 Stafford residents such as Medicaid, SNAP (formerly Food Stamps) and Adoption?
- 5. Which Constitutional Officer is responsible for the enforcement of local codes, the Emergency Response Center, court security and crime prevention?
- 6. This department provides professional, courteous and intelligent solutions to the waste disposal needs of citizens and commercial waste haulers in Stafford County and the City of Fredericksburg.
- 7. Our motto is "Connecting the Community" and that is what we work towards every day and we work to preserve Stafford's past by maintaining historic resources.
- 8. This department implements policies that support balanced growth and development, including recommendations for conservation of natural and cultural resources, and agricultural/forestry and open space lands.
- 9. This department develops strategy and standards for the delivery of technology services for County staff and the public.
- 10. This department provides strategic and collaborative human resource leadership and solutions to recruit, develop, motive and retain a diverse high-performing workforce.



- 11. We have 190 career and 150 volunteer personnel operating out of 12 fire and rescue facilities. We also have a Citizens Emergency Response Team, or CERT, that is made up of more than 50 volunteers who perform a wide range of services to the community and our department.
- 12. This department coordinates the issuance of debt for large capital projects for which borrowed funds are necessary. This work involves coordination with departments and agencies to determine the timing of the debt issuances to ensure funds are available when needed, and participation with state bodies such as the Virginia Resources Authority (VRA) and the Virginia Public School Authority (VPSA) for pooled financings.
- 13. This department is the marketing and sales arm for Stafford we encourage business expansion and investment, including tourism marketing and sports tourism.
- 14. This department is responsible for facilitating the processes associated with residential, commercial and industrial development in Stafford County. This would include the Building Division, Environmental Division, Community Development Service Center (Permits), and Developer Securities.
- 15. This office provides adaptive and creative legal solutions and is appointed by the Board of Supervisors and serves as its chief legal advisor.
- 16. This Constitutional Office is the Chief Assessing Officer for Stafford County. It is the job of my office to identify and value all taxable property within the county so that I can prepare the tax roll to give to the Treasurer for the collection of taxes.
- 17. One responsibility of this office is to inform the Board of Supervisors and County Administrator of the impact of legislation before the Congress and the Virginia General Assembly.
- 18. This department aligns the strategic plan with the budget, long range financial forecasting and capital needs. The department partners with County Administration, the county departments and community partners to recommend the best use of public resources in pursuit of Board of Supervisor's (BOS) goals.
